





NEW LAW ENFORCEMENT RIAS

Request for Investigation Assistance (RIA)

The RIA process provides LELs with the ability to reach scores of private health insurers in one simple step for assistance in health care fraud investigations. The identification of additional fraud victims and dollars lost, due to fraud, are important elements in the investigation process. Please <u>click here</u> to view the procedures to submit an RIA.

During the month of April, **3 RIAs** were submitted by law enforcement, and notifications were sent to authorized SIRIS[®] users*.

SIRIS[®] users authorized to access RIAs is restricted to Membership Forum Representatives and/or their delegates whose organization has signed an Information-Sharing Agreement with NHCAA.

SIRIS[®] TIPS

- Provider Case vs. Scheme: A SIRIS Provider Case allows users to enter specific information
 on a provider that is suspected of fraudulent behavior. A SIRIS Scheme, rather, is intended to
 capture the behavior of multiple providers. Therefore, a SIRIS Scheme should not include the
 provider's name or identification numbers. Please note that when adding or editing a Scheme,
 SIRIS users can link a related SIRIS Provider Case to the Scheme by completing the Related
 SIRIS Provider Case #s field.
- **PHI in SIRIS?** Patient Personal Health Information (PHI) is <u>never</u> allowed in SIRIS. Please do not enter this information in a SIRIS Provider Case, Scheme, or RIA. If PHI is found, please report it to <u>fraud@nhcaa.org</u> so NHCAA can remove the information from SIRIS.
- New URL for SIRIS[®]: In conjunction with a SIRIS[®] security update, the SIRIS[®] URL has been changed. Please use <u>https://siris.lexisnexisrisk.com/</u> or <u>https://nhcaa.lexisnexisrisk.com/</u> to log into SIRIS[®]. *Please remember to change the URL on any bookmarks you may have set for SIRIS*[®]. The old link is no longer active.
 - If you find you are unable to access the new SIRIS[®] site, one tip is to disconnect from your company's VPN to access SIRIS[®].
 - Alternatively, you may need request that your IT department approves the following IP addresses (Boca: <u>209.243.49.209</u> and Alpharetta: <u>69.84.186.134</u>) along with the new URLs to ensure your company's firewall is not blocking access to the SIRIS[®] database.
- Suspended? Users' access to SIRIS[®] will automatically suspend if a user enters an incorrect password more than 3 times, or if a user has not signed in to SIRIS[®] in more than 90 days. Suspended users who want their SIRIS[®] ID reactivated should submit their request to NHCAA at <u>fraud@nhcaa.org</u>.

SIRIS[®] ADMIN CORNER

- User ID Creation Process: The SIRIS UserID will be automatically generated upon completion
 of the "Create New User" form. The UserID is based on the format SRSFirstInitialLastName & will
 not be editable. If the UserID already exists, it will be appended with numeric values at the end.
 E.g., John Smith would be SRSJSmith and if the UserID already exists, it would be
 SRSJSmith01.
- Removing Access to SIRIS: SIRIS admins should follow these steps to remove users that no longer need access to SIRIS:
 - 1. Uncheck all permissions, including "Can Access SIRIS."
 - a. If the user is an Admin or has access to the RIA module be sure to contact <u>NHCAA</u> to remove these permissions.
 - 2. If the SIRIS user also has an Accurint account be sure to remove the individual from SIRIS first, then from Accurint.
 - 3. <u>When should I remove a user's access</u>? Admins should remove user's access to the SIRIS database when the user leaves the company or no longer has SIU responsibilities.
