## What is the optimal browser for viewing the sessions?

Here are the recommended browsers for optimal viewing of the Annual Training Conference. Additional technical information is available in the 'System Requirements' document.

- 1. Windows: Chrome 72+, Edge 84+, Firefox 27+, IE 11
- 2. Mac: Chrome 30+, Safari 7+, Edge 84+, or Firefox 27+
- 3. Linux: Chrome 30+, Firefox 27+

#### Are the sessions live or recorded?

- All of the sessions are pre-recorded, but our speakers are available live in the chat section of each session. Ask your questions in real-time.
- On Friday, the workshops all have live zoom discussions for 15 minutes after each session.

#### How do I receive Continuing Professional Education (CPE) credits for attending the virtual meeting?

- This program is worth 16 CPEs.
- You need to attend at least 9 of the 15 time slots across the conference. This is 60% of conference sessions.
- NHCAA will reach out to eligible attendees with a link to claim your credit and personalized certificate.

#### How do I earn the credits for AAPC?

- You need to attend at least 9 of the 15 time slots across the conference. This is 60% of conference sessions.
