





## **NEW LAW ENFORCEMENT RIAS**

#### **Request for Investigation Assistance (RIA)**

The RIA process provides law enforcement agencies with the ability to reach scores of private health insurers in one simple step for assistance in health care fraud investigations. The identification of additional fraud victims and dollars lost due to fraud are crucial elements in the investigation process. Please <u>click here</u> to view the procedures to submit an RIA.

During the month of February, **4 RIAs** were submitted by law enforcement and notifications were sent to authorized SIRIS<sup>®</sup> users\*.

SIRIS<sup>®</sup> users authorized to access RIAs are restricted to Membership Forum Representatives and/or their delegates whose organization has signed an Information-Sharing Agreement with NHCAA.

### SIRIS<sup>®</sup> TIPS

- Estimated Dollar Exposure: When adding new provider cases into SIRIS<sup>®</sup>, it is best to add an estimated dollar exposure to your entry based on the pool of suspicious claims identified.
- Provider Case Notifications: SIRIS<sup>®</sup> users entering provider cases have the option to receive an email reminder to revisit their entries. The timeframe options for these reminders are Never, 30-, 60-, or 90-day intervals. The owner of the case will receive an email reminder in accordance with the selected notification period. Note: If a notification period is selected and the record is modified at any point prior to notification expiration the timeframe starts over again.
- **Remain Active in SIRIS**<sup>®</sup>: Sign in at least once every 90 days to avoid suspension. SIRIS<sup>®</sup> will send an email notification 14 days prior to deactivation to remind the inactive user to sign on.
- Suspended? Users' access to SIRIS<sup>®</sup> will automatically suspend if a user enters an incorrect password more than 3 times, or if a user has not signed into SIRIS<sup>®</sup> in more than 90 days. Suspended users who want their SIRIS<sup>®</sup> ID reactivated should submit their request to NHCAA at <u>fraud@nhcaa.org</u>.

### SIRIS<sup>®</sup> ADMIN CORNER

 User ID Creation Process: The SIRIS<sup>®</sup> ID will be automatically generated upon completion of the "Create New User" form. The ID is based on the format SRSFirstInitialLastName and will not be editable. If the ID already exists, it will be appended with numeric values at the end. For example, John Smith would be SRSJSmith and if the ID already exists, it would be SRSJSmith01.

<u>Note</u>: Before creating new SIRIS<sup>®</sup> IDs, please be sure to check that the user does not already have an ID. If an ID exists, but is suspended, please email NHCAA at <u>fraud@nhcaa.org</u> to request reactivation.

- Removing Access to SIRIS<sup>®</sup>: In order to remove staff from SIRIS<sup>®</sup>, administrators should follow these steps:
  - 1. Uncheck all permissions, including "Can Access SIRIS<sup>®</sup>."
    - a. If the user is an Admin or has access to the RIA module be sure to contact <u>NHCAA</u> to remove these permissions.
  - 2. If the SIRIS<sup>®</sup> user also has an Accurint account be sure to remove the individual from SIRIS<sup>®</sup> first, then from Accurint.
  - When should I remove a user's access? Admins should remove user's access to the SIRIS<sup>®</sup> database when the user leaves the company or no longer has SIU responsibilities.
