MEMBER TUITION-FREE REGISTRATIONS

The Membership Forum Representative from each organization will designate tuition-free registrations. Check with your representative for availability. National Association of Medicaid Fraud Control Units manages tuition-free registration for Medicaid Fraud Control Units.

- ▶ NHCAA Member Organizations, Affiliate Members, and National Government Liaisons can designate two (2) tuition-free registrations for each virtual and in person program, excluding the Data Analytics Program and ATC.
